

End the Transcript Trap in Connecticut

Across the country, many institutions of higher education withhold transcripts for students who have any amount of unpaid balance.

100% of Connecticut institutions of higher education explicitly use this practice in 2022.¹

This punitive approach to debt collections, even for low dollar amounts, unfairly prevents students from being able to claim the credits they have already earned on the way to a degree—impeding their ability to get jobs or transfer to other academic programs. The practice also disproportionately harms low-income students and perpetuates a cycle of poverty.

It's time to end the Transcript Trap in Connecticut.

The Serious Implications to Withholding Students' Transcripts:

- Impedes students' ability to get jobs and pay off their debts, ironically.
- Prevents students from transferring credits they have earned so that they can pursue a different career path.

Disproportionate Impact on Low-Income Students:

- The Transcript Trap perpetuates the cycle of poverty by targeting the credentials of students with debt.
- Even Connecticut's community colleges—which are specifically advertised as being both affordable and transfer-friendly—use this practice.

National Trends to End the Transcript Trap:

- In 2019, <u>California</u> banned the practice in public and private colleges.
- In 2020, <u>Washington</u> made releasing transcripts a requirement when students are applying for jobs.
- Massachusetts, Minnesota, and New York all saw legislation pushing to ban the practice in 2021.
- The City University of New York (<u>CUNY</u>) announced that it would suspend the practice for Fall 2021.

¹ We researched this practice at 34 institutions of higher education, including all in-state, regionally accredited, non-profit institutions; state-supported institutions; and community colleges. 30 of the 34 either explicitly confirmed that they engage this practice or printed information about it on their website or catalogues. The remaining four have not yet responded to requests for information. Our research does not include out-of-state institutions that are licensed in Connecticut, St. Thomas Seminary, or the US Coast Guard.

University of New Haven	Private, 4-Year College	Yes "If your bill remains unpaid for one month or more, a financial hold will be placed on your account. This financial hold will prevent you from registering for future semesters, requesting your academic transcript, viewing grades" (Source: Student Handbook)
